A Mother's Love: Rose **Devoe Honors Her Son** Gabriel Through Advocacy and Hope

When Rose Devoe speaks about her son Gabriel, her voice carries a warmth and sorrow that lingers. Gabriel Devoe, a student at Valdosta State University was known for his vibrant spirit, infectious smile, and impeccable style. "He brought light to the room," Rose recalls. "He brought light to our lives."

Gabriel's life was miraculous from the start. Doctors once told Rose her baby had no heartbeat—despite undergoing a D&C procedure—a heartbeat would later appear. Doctors then said that her son wouldn't be viable or would be deformed. Rose decided to trust the Lord's plan and love her son. Against all odds, Gabriel was born healthy and full of life. He defied every expectation and grew into a confident, compassionate young man with dreams that matched his limitless energy.

In November 2022, his life was tragically cut short when he was senselessly murdered. Today, his case remains unsolved.

In a powerful act of grace, Valdosta State University awarded Gabriel his degree posthumously, recognizing the work he had completed and the promise he held. The gesture deeply moved Rose and her family.

At his memorial, friends recalled how Gabriel needed

a two-hour head start just to get dressed. His charm and sense of style made him unforgettable. But beyond the outward presence was a young man grounded in faith, family, and love.

In the aftermath of tragedy, Rose founded the Gabriel John Devoe (GJD) Foundation. It is a testament to a mother's enduring love and her refusal to let her son's story end in silence. The GJD Foundation offers support to grieving families, uplifts underserved communities, fights gun violence, and raises awareness about unsolved homicides. Through her advocacy, Rose has turned grief into purpose. "Every day, I wake up and ask God to give me the strength to speak Gabriel's name," she says. "If I don't speak for him, who will?"

As the investigation continues, Rose refuses to give up. Her mission is not just about solving crime, it's about healing, remembrance, and ensuring no other parent has to face this pain alone.

Rose also credits the Justice Coalition for helping her stay strong in her fight for answers and accountability. "They gave me a voice when I didn't know how to use mine," she said. "They reminded me I wasn't alone, and that Gabriel's life mattered."

Gabriel's light still shines. His life had purpose. His story matters. Say his name. Support the mission. Help bring justice for Gabriel John Devoe.

In 1995, Hires founded the Justice Coalition with a mission rooted in service, transparency, and advocacy for crime victims and their families. Α former businessman turned community activist, Hires launched the Coalition after his own life was touched by tragedy. What began as a personal mission quickly became a city-wide effort to protect the innocent, support survivors, and ensure the justice system worked for the people it was meant to serve.

Now, three decades later, the Justice Coalition is celebrating its 30th anniversary and the relaunch of its flagship publication with a renewed commitment to the cause. "We've never stopped," said Exective Director and longtime staff member Robert Bracewell. "We've kept fighting for victims, for transparency, and for justice—no

matter how tough the road has been."

Attorney General Uthmeier Adds Victim Tampering Count to Man Charged With Trafficking a Minor



Statewide Prosecution has added a count of victim tampering against a defendant already charged with human trafficking of a minor. While in pretrial detention at Wakulla County Jail, authorities intercepted three letters sent by Sky Skidmore to the victim, the victim's mother, and Skidmore's mother. These letters were intended to intimidate the victim.

"This defendant, who is currently in pretrial detention for committing heinous acts of human trafficking against a minor, chose to escalate his terrible situation by sending letters to intimidate and deter the victim from testifying at trial," said Attorney General James uthmeier. "Our Statewide Prosecutors have added this additional charge for this human trafficker and will continue to work diligently to hold him accountable for his atrocious crimes."







Honoring the Founder of the *Justice Coalition*

When Ted Hires founded the Justice Coalition in 1995, he wasn't looking for praise or politics. he was searching for justice. After experiencing the devastating effects of violent crime in his own family, Hires committed his life to helping others navigate the very system that had once failed him.

What started as a personal crusade quickly became one of the most important victim advocacy organizations in the state of Florida. Through the Justice Coalition, Hires gave a voice to those who had been silenced-victims, survivors, and families devastated by crime. He made sure they were seen, heard, and supported in every courtroom and legislative chamber that would listen.

A former restaurant owner, Hires brought business savvy and tenacious leadership to a cause that was deeply personal. He built partnerships with law enforcement, prosecutors, and elected officials. he created educational programs, fought for victim rights legislation, and held public officials accountable. But most importantly, he sat with grieving mothers, stood beside broken families, and reminded them that justice was still possible.

Hires made sure victims knew their rights, understood the court process, and had advocates at every step of their journey. His mission was simple: no one should face the justice system alone.

Over the years, the organization launched a wide range of initiatives, including courtroom advocacy, community

Hire's legacy also lives on through legislation. He was instrumental in pushing for laws that enhanced victims' rights, increased penalties for violent offenders, and demanded greater transparency in the system. His efforts helped build a foundation that the Justice Coalition still stands on today.

Though Ted Hires passed away in 2017, his vision and passion remain the driving force behind everything the Justice Coalition does. His memory is woven into every victim service, every courtroom visit, and every newspaper column that bears witness to the fight for justice.


