The Rule of Law: Honoring Marsy's Law and Michael Liles' Legacy

In 1983, the family of Marsalee "Marsy" Nicholas suffered an unimaginable blow. Just days after her murder, her brother Dr. Henry Nicholas and his family unexpectedly confronted her killer in a grocery store. Released on bail without their knowledge, the shock of that encounter inspired Dr. Nicholas to launch a movement. Marsy's Law was born—a nationwide effort to ensure crime victims' rights would stand equal to those of the accused.

In Florida, that fight found a powerful voice in Michael Liles, executive director of the Justice Coalition. His wife, Debbie—a beloved teacher, musician, Christian, and grandmother of eight—was brutally murdered in 2017 during a home invasion. Instead of retreating into grief, Michael carried Debbie's memory forward, becoming a key spokesperson for Amendment 6, which enshrined Marsy's Law into the Florida Constitution.

Marsy's Law guarantees victims notification of hearings, the right to be heard in court, protection from intimidation, access to information, and restitution. It ensures fairness and dignity, elevating victims to equal standing with defendants. Michael believed in that principle: nothing more, nothing less.

In 2018, Michael and Debbie's children—Michelle, Dana, Gerald, Rockey, and Rachel—embraced a rare approach: restorative justice. With State Attorney Melissa Nelson's support, they confronted Debbie's killer. Their agreement was simple: if he answered their questions truthfully, he would plead guilty and accept life in prison instead of the death penalty.

The family sought answers: Did Debbie fight back? Why their family? Was there an accomplice? Dana held a note Debbie once wrote to her grandson, about rockets "shooting up to God." Michelle demanded the killer face the crime-scene photos of their mother. Gerald, torn after reading about the killer's traumatic childhood, insisted "every life has value."

But answers never came. Still, the murderer pleaded guilty to four charges, including first-degree murder, and received a life sentence. For the Liles family, justice was imperfect, but closure came in confronting him face-to-face. Michael carried that pain until his death, which friends believe came from a broken heart. Yet his legacy lives on in Marsy's Law, in protections for victims' privacy, and in the voices he helped elevate across Florida.

As Justice Coalition founder Ted Hires once said, "The criminal justice system doesn't discriminate—it treats all victims like dirt." Michael proved one person can make a difference. His courage, advocacy, and devotion to Debbie helped ensure victims will never again be treated as afterthoughts, but as equals in the pursuit of justice.

A Mother's 30-Year Fight for Justice

Justice Coalition Continues To Give Victims A Voice

When May Martinez's daughter, Colleen Slemmer, left Orange Park, Florida, for Knoxville, Tennessee, on October 31, 1994, no one could have imagined the horror that awaited her. Colleen, just 19 years old, had enrolled in Computer Job Corps training with dreams for her future. Less than three months later, on January 13, 1995, she was brutally murdered in one of Tennessee's most notorious crimes.

Three students lured Colleen under the pretense of renting movies, took her to the University of Tennessee campus, and murdered her in an attack so vicious it shocked the nation. Her killers carved a five-point pentagram into her chest and kept a piece of her skull as a grisly souvenir, claiming it was for a human sacrifice. The ringleader, Christa Gail Pike, later displayed a fragment of Colleen's skull to other students at breakfast

In the aftermath, May Martinez was left to navigate the legal system across state lines, with little guidance or compassion. "I didn't know how to handle the process, and I was completely alone," she

recalls. That changed when she met Ted Hires in 1995, shortly after he founded the Justice Coalition and launched the Victim's Advocate

"Ted helped me understand what would happen and guided me through legal matters, even though my case was in Tennessee," Martinez said. "This newspaper has always been essential for victims. It gives people information, direction, and emotional support. It allows victims to tell their stories, so they're not forgotten."

For nearly three decades, Martinez has endured the painful realities of the justice system. Evidence from Colleen's case was withheld for years. After 18 years, Martinez was handed her daughter's skull in a box at the airport, where she and Ann Dugger of the Justice Coalition had to count each piece alongside a judge. Meanwhile, Pike—who remains on death row but now lives in general prison population—dismissed the proceedings, saying she wanted to return to her cell

The agony continued when Martinez received body parts in the mail with no explanation, no labeling—just her name on the box. "I opened it, and inside were pieces

of my daughter," she said. She has had to reopen Colleen's grave in Pennsylvania three times to lay her remains to rest, each time seeking a judge's order. Adding to the pain, Pike has been able to profit from prison work and media appearances, publicly speaking about the murder that devastated Martinez's life. "She talks about what she did to Colleen like it's entertainment, while we, the victims, get no help," Martinez said. Martinez insists that her experiences drives home why Jacksonville can't afford to lose the Victims' Advocate. "Victims need a place to go when the legal system fails them. They need guidance, direction, support, and someone who understands what they're going

they're going through," she said.

For Martinez, the Justice Coalition remains more than just a nonprofit or a publication—it is a lifeline for families facing unthinkable loss. "The Justice Coalition and its newspaper are vital. They give victims hope, direction, and a voice," she said.

As Jacksonville continues to confront senseless crime and violence, Martinez's plea is clear: the Victim's Advocate must remain, so no other family has to walk alone through the darkness of tragedy.

Attorney General Uthmeier Announces 20-Year Prison Sentence For Human Trafficker



Attorney General James Uthmeier announced that Sky Skidmore has been sentenced to 20 years in the Florida Department of Corrections, followed by 10 years of sexual offender probation, for human trafficking and related crimes. Skidmore was also designated a sex offender.

"Human trafficking and the exploitation of children are among the most heinous crimes imaginable," said Attorney General James Uthmeier. "This predator stole innocence and tried to silence his victim. The sentence secured by Senior Assistant Statewide Prosecutor Guillermo Vallejo ensures he will never again have the chance to harm a child."

Skidmore pled guilty to human trafficking for commercial sexual activity, lewd or lascivious battery, promoting a sexual performance by a child, tampering with a victim, and use of a two-way device to commit a felony.

In 2023, investigators discovered Skidmore was exploiting a minor for commercial sex. He used various social media platforms, including Facebook and Snapchat, to communicate with the victim and coerced her into performing lewd acts.

Evidence showed that Skidmore sexually abused the victim, promoted the production of child sexual performance materials, and later attempted to intimidate and tamper with the victim during the ongoing case.

The investigation was a joint effort by the Florida Department of Law Enforcement, Leon County Sheriff's Office, Wakulla County Sheriff's Office, Tallahassee Police Department, and the Office of Statewide Prosecution.

BE ON THE LOOKOUT





SJSO and FBI Jacksonville continue to investigate the April 9, 2025, armed robbery at Ameris Bank, 4070 US1 South, in St. Augustine.

On April 9, the suspect is seen on surveillance video walking into the bank at 10:57am armed with a black semi-automatic handgun. The suspect ordered the bank employees away from the teller stations, climbed over the counter, removed cash from four stations and placed it into a plastic "Publix" shopping bag.

The suspect was in the bank for approximately one minute and twenty seconds and fled on foot. He is captured on surveillance video at a nearby business walking south on a jogging trail toward Palermo Road immediately after the robbery.

The suspect wore an "Ozark" snorkel mask, black neck gaiter, grey hooded sweatshirt and sweatpants, vinyl gloves, and white Adidas running shoes. The suspect is a white male with a thin athletic build, blonde or sandy colored hair, and is approximately 5'10" tall.







Justice Coalition Marks 30 Years with Anniversary Celebration and Newspaper Relaunch

On July 29, 2025, the Justice Coalition celebrated its 30th anniversary at the Duval County Courthouse with a memorable ceremony that also marked the relaunch of the Victim's Advocate newspaper. The event honored the vision of founder Ted Hires, reflected on decades of advocacy for victims, and looked ahead to continuing the mission of serving families impacted by crime.

The courthouse lobby displayed decades of history through "Through the Years" boards filled with photographs, old newspapers, and stories. Many of the displays featured Ted Hires' words in print, along with a powerful video recorded by John Walsh of America's Most Wanted reenacting the robbery that inspired Hires to start the Justice Coalition in 1995. Walsh called the organization a model for the nation, saying it "should be duplicated in every city in America."

Honoring Founders and Leaders

Included mayors, governors, law enforcement officers, court staff, legislators, clergy, attorneys, and community leaders who have supported the organization through the years. Photos of victims and families helped by the Justice Coalition highlighted the heart of the mission—standing with victims in their time of need.

The program began with emcee Ashley Harding reflecting on the organization's history, followed by Pastor Amos Bankhead's invocation and the Jacksonville Sheriff's Office Honor Guard presenting the colors. Chief Judge Lance Day recalled meeting Hires early in his career, remembering his challenge to prosecutors: "Don't sit on your apathy, you've got work to do."

Congressman John Rutherford praised the Coalition's close work with the Jacksonville Sheriff's Office during his time as sheriff, while the Honorable Eric Smith highlighted the organization's role in victim services.

Executive Director Robert Bracewell presented the Ted Hires video with John Walsh, underscoring the Coalition's lasting impact. Board Chair and victim advocate Andrea Crutchfield spoke of the loss of her son Brandon Blansit, saying the Justice Coalition "saved her life" after his murder. Longtime volunteer and board member Foster Coker shared his harrowing encounter with gang violence, crediting the Coalition for empowering victims like himself to speak out.



A Legacy Continued

The ceremony culminated in the unveiling of the Victim's Advocate newspaper by Ted and Wanda Hires' son, Wesly Hires, with a special acknowledgment of Wanda's decades of dedication. The crowd responded with a standing ovation for Executive Director Bracewell and the Justice Coalition team for their commitment to victims.
