#### The Boys Who Never Came Home: 20 Years of Questions and Hope

Some stories do not fade with time. They linger... with unanswered questions. Those who have lived in Jacksonville since the early 2000's likely know the names, Mark Degner and Bryan Hayes. The boys who walked away from Paxon Middle School and never were seen again. The mystery around their disappearance is still talked about today.

This February marked 20 years since the last time the boys were seen alive. It all began on the cold morning of February 10, 2025. Mark Degner, 12, and Bryan Hayes, 13, both attended Paxon Middle School and were last seen around 1:30pm walking away from the school across the baseball grounds. According to witnesses, no one else was with them.

At home, Mark's sister, Brittany, was doing homework when her mother came in asking if she'd seen him. "We can't find your brother anywhere," she told her. Brittany began searching the neighborhood but found nothing. Police were called, and soon it became clear Bryan was missing, too. Flyers were printed, TV stations aired their faces, and volunteers searched—but there was no trace.

The boys hadn't taken anything with them: no money, clothing, or belongings. Detectives from the Jacksonville Sheriff's Office chased every lead. They even traveled to South Florida after a possible sighting but it led nowhere. Investigators explored a potential link to Ron Hyde, later convicted in the 1994 murder of teenager Fred Laster, but that connection also fell flat. Years became decades. The case grew cold.

Though often remembered as "the missing boys," Mark and Bryan would be in their 30s today. Both were known for their humor and kindness-Mark for his thick Southern drawl and love of animals, Bryan for his gentle spirit and fondness for flowers. Their families still hold out hope for their safe return.

In a 2017 interview, Bryan's mother, Alene Hayes, shared how deeply his brothers missed him. "We really miss him at Christmas," she said. "He always wanted to decorate the tree and did a beautiful job."

On the 20th anniversary, Mark's grandmother, Darlene Briggs, released a statement through the National Center for Missing and Exploited Children: "Our family is truly thankful for the needed support and encouragement from the community, our public officials, the many efforts of law enforcement in their continued search, and the media as they keep community awareness that our missing loved ones are not forgotten. Our hearts are filled with hope as we pray for God's protection, provision and safe return of all our missing

The Degner family says they still hold out hope that they will be reunited one day. Detectives want Mark and Bryan to know they're not in trouble. Their families and officers just want to know they're safe.

The Justice Coalition's director, Robert Bracewell, says he is re-establishing the reward of \$10,000 for information leading to the whereabouts of Mark Degner and/or Bryan Hayes. Not all incidents qualify as a criminal offense, but many can escalate into more serious crimes such as battery, assault, sexual violence, or kidnapping.

# **Attorney General Uthmeier Targets Tech Giants** Over Child Safety, Parental Rights

Attorney General James Uthmeier is taking aim at major tech platforms accused of endangering children sold children's personal data, including voice and violating parental rights.





# JSO's Missing Persons Unit Leads the Way in Locating the Vulnerable

The Jacksonville Sheriff's Office Missing Persons Unit (MPU) is on the front lines of one of the city's most delicate responsibilities—locating missing children, adults, and vulnerable individuals. With just seven detectives and a sergeant, the unit investigates more than 3,000 cases every year, ranging from juvenile runaways and voluntary disappearances to cases involving foul play, mental illness, and cognitive disabilities.

Each case begins with a patrol officer's initial report. Within 24 hours of assignment, a detective makes the first call to a family member, and the case remains active until the individual is found. Detectives use a wide range of tools—placing flyers, canvassing neighborhoods, coordinating with patrol officers, and when necessary, calling on the resources of the Florida Department of Law Enforcement (FDLE) and the FBI. By law, dental records must be obtained at the 30-day mark and DNA samples at 90 days, ensuring thorough case tracking under state statutes.

#### Innovative Programs to Protect the Vulnerable Recognizing that time is critical in missing person cases, JSO has launched several

person cases, JSO has launched several groundbreaking initiatives to increase recovery rates:

 MEPSAR (Missing Endangered Persons Search and Rescue): Started in 2021, this joint program with Jacksonville Fire and Rescue boasts a 99.6% recovery rate. It uses real-time data and coordinated search tactics to locate missing individuals quickly.

REVAMP (Registry for Endangered, Vulnerable, and Missing Persons): A voluntary registry where families can provide detailed information about their loved one—including photos, medical diagnoses, and personal tendencies—before a crisis occurs. The data is secured under HIPAA and CJIS standards and is only accessed in emergencies, saving valuable time when a search begins.

• Scent Preservation Kits: Funded through Florida's "Bring the Lost Home" appropriation, these kits allow families to store a clean scent sample of a loved one for use by bloodhounds. Unlike improvised items like pillowcases, which can be contaminated, these samples enable faster, more accurate tracking.

Awareness Sticker Program: Special decals placed on vehicles and homes alert first responders that an individual inside may have cognitive disabilities, helping officers adjust their approach during an encounter.

 CareTrak Electronic Monitoring: Made possible through the Kevin & Avonte federal grant, this program provides electronic trackers for individuals prone to wandering. With it, MPU officers have reduced searches that might take days to just one or two hours.

#### A Commitment to Jacksonville Families

Sgt. M.C. Monts, who leads the unit, emphasizes that every case is different but treated with the same urgency and care. "Our detectives may not be perfect, but they are the best of the best," Monts said. "They do their jobs with an amazing ability and heart for the individuals they are searching for."

The MPU's work reflects an evolving partnership between law enforcement, first responders, and the community. By combining traditional detective work with innovative tools and programs, JSO has positioned itself as a leader in protecting Jacksonville's most vulnerable residents. 

Investigative efforts and help from Volusia Sheriff's Office Detectives confirmed the remains belonged to Abel. The investigation spans hundreds of miles across several Florida counties, but to this day, his death remains a mystery. 


